## **TUITION FEES FOR GOVERNMENT-SUBSIDISED GRADUATE PROGRAMMES**

# Admitted before August 2022

### Reminder:

### **Tuition Fee beyond Normal and Maximum Candidature Period**

With effect from of AY2019/2020, students admitted into a government-subsidised graduate coursework degree programme and who take longer than the <u>normal candidature period (NCD)</u> to complete their degree requirements will have to pay full unsubsidized fees, during the extended semesters.

Students who are admitted prior to AY2019/2020, will continue to pay subsidised fees until their maximum candidature period. Those who take longer than the maximum candidature period is required to pay full unsubsidised fees, during their extended semesters.

### **IMPORTANT NOTES:**

- i. The fees listed are in Singapore Dollars (SGD). Amount is subjected to the prevailing Goods and Services Tax (GST) rate.
- ii. The payment of the programme tuition fees for cohorts of AY2022/2023 onwards is split into 2 payment schedule and to be paid over 2 semesters for full-time students; whereas it is split into 4 payment schedule and to be paid over 4 semesters for part-time students.
- iii. The payment of the tuition fees for existing students (i.e. cohorts prior to AY2022/2023) under the government-subsidised graduate programme is on per semester basis, subject to the Normal Candidature (NCD) period as stated at the Office of the University Registrar (OUR).
- iv. Full payment of programme tuition fee is required before completion and award of the degree.
- v. All students are liable to pay the **Miscellaneous Student Fees (MSF)** on a semester basis, for the entire candidature separately. This is apart from the programme fee. Details of the miscellaneous student fees payable are available at Office of the University Registrar (OUR).
- vi. Payment of the tuition and miscellaneous student fees are to be made by the stipulated due date set by Office of Finance. If fees are not paid or only partially paid by the due date, a late payment charge may be imposed by NUS.
- vii. Additional tuition fees will be charged if student is unable to complete the degree requirement within the maximum candidature period. This will be subject to approval on a case-by-case basis.
- viii. Tuition fees are reviewed annually and is subject to revisions.
- ix. The cost of travels, accommodation, and other miscellaneous expenses are not included in the total programme fees and are to be borne by the students themselves. For an estimated cost of living in Singapore, you may use this guide calculator from an external site as a reference.
- x. Programme fees do not include the costs of recommended textbooks and readings.
- xi. If the payment schedule by a student deviates from the published fees and payment schedule table for the applicable intake (for example, due to approved Leave of Absence (LOA) for the semester), the applicable prevailing GST rate will apply.
